**The purchase cost of the additional work order is approximately of Rs. 11,00,00,000/- (Rupees Eleven Crore Only).**

After the receipt of an additional work Order, the total purchase value of the orders from the Railtel Corporation stands for **Rs. 29,14,74,682/- (Rupees Twenty Nine Crore Fourteen Lakh Seventy-Four Thousand Six Hundred Eighty-Two Only).**

  - b) The candidates so engaged will work purely on outsourced basis and they will be on the roll of M/s SBC Exports Limited. They will have no right over the RailTel and they cannot be inducted on the roll of Railtel.
  - c) Railtel will not issue any experience certificate/ service certificate to the employees on leaving the job. Agency will issue such letters but only after obtaining NOC from Railtel.

  - e) Railtel may terminate the contract, by giving 7 (seven) days written notice of termination to the M/S SBC Exports Limited.
  - f) M/S SBC Exports Limited shall perform the services and carry out their obligations with all due diligence, efficiency and economy in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate technology and safe methods.
  - g) The parties hereby irrevocable consent to the sole jurisdictions of the Courts of Mumbai only in connection with any actions or proceedings arising out of or in relation to this Tender.
